And without limiting the generality of this indemnity I agree that it shall extend to and cover all and any claims and damage in respect of disability, injury, medical, hospital or chemist accounts, delays, loss of earnings and loss of property and whether or not such claims or damage arise from the negligence or carelessness of the said CORPORATION OR THE APPOINTED SKIPPER, or any member of the crew or passengers or guests, whether arising onboard the said Yacht or not and whether arising on the Yacht's business or otherwise.

I have been fully informed as to the inherent hazards of the East Coast of Africa and the sport of yachting. I understand that all arrangements are strictly subject to weather conditions and as such at the sole and final decision of the CORPORATION OR THE APPOINTED SKIPPER and agree to abide by same and at all times to abide by their directions.

I acknowledge that it is on the basis of this indemnity that I shall be taken onboard the said Yacht.

Conditions of this Charter Ticket



1. This ticket shall be invalid unless the indemnity overleaf is signed and
2. Permission to board will be refused to any charter guest that has not signed the indemnity overleaf and the acceptance below.
3. This ticket will only be issued upon full pre payment of the charter
4. No refunds will be applicable once this ticket is issued
5. By accepting this ticket the holder agrees to submit to the absolute authority of the skipper as captain of the vessel being boarded for the duration of the charter.
6. Persons carrying equipment or objects or wearing apparel that could cause damage to the vessel will not be allowed to board the vessel with such object equipment or apparel.
7. The ticket holder shall conform with any maritime, vessel, navigational, weather and safety regulations announced by the captain or crew
8. No smoking is allowed below decks. Cigarettes, cigars or pipes may not be extinguished against any part of the vessel.
9. Passengers must always act in the best interest of other passengers and the crew of the vessel.
10. The Captain may at his or her sole discretion return passengers to the passenger jetty who are considered (at the sole discretion of the captain) a nuisance, abusive, threatening, dangerous (including to themselves), to other passengers, the crew, the captain or other vessels and their passengers.
11. Passengers may not interfere with the sails, rigging, tackle, superstructure, machinery, electronics or the crew of the vessel.
12. Children under the age of 12 must be accompanied by a parent or teacher who shall take full responsibility for their charge.
13. Any damage cause to the vessel by any passenger will be for the passengers account.
14. Passengers may not impair the captain or crew of the vessel in any way.
15. Passengers may not jump overboard or enter the water unless proper prior arrangement has been made with the captain.
