Application refused based on a nebulous locus standi argument by the prosecutor. From that moment on we were tailed by members of National Intelligence

## 5. High Court Johannesburg

Appeal re judgment on locus standi and reiteration of importance of evidence in the public interest, allegation of impression of corruption extending to magistrate.

Application refused based on argument by Magistrates legal representative that the constitutional right was outside the jurisdiction of the high court. The hearing was attended by a sizeable contingent of the Witwatersrand University Law faculty, who urged me to take the matter to the Constitutional Court.

- 1. Was subjected to silenced sniper fire minutes after the **application to the Constitutional Court** was served.
- 2. Spent 8 months incognito in the Northern Cape until the evidence (micro tapes) could be delivered to and then presented to court by an advocate from the Cape Town Bar. Questions were raised in parliament by leaders of opposition parties
- 3. NI agents were incarcerated. One for the murder of a colleague, his wife and a 4 year old child.
